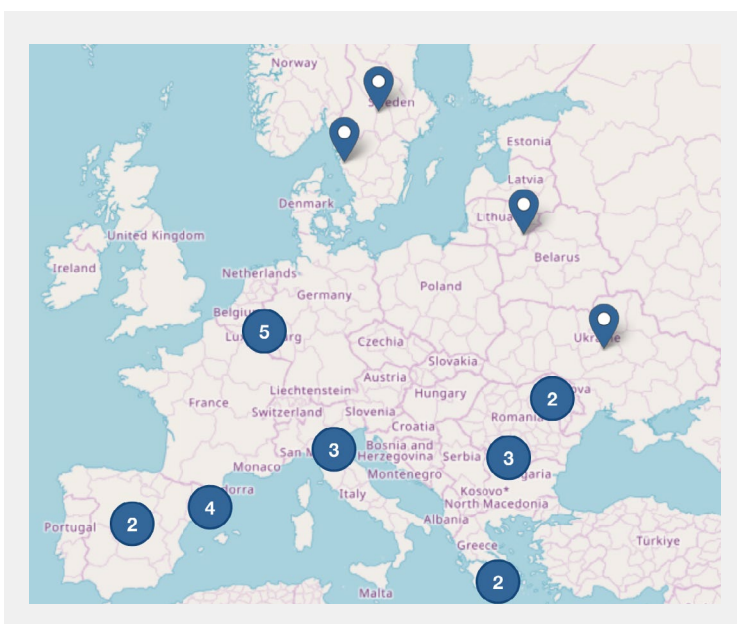
LEADING THE NEW WAVE OF DEEP TECH INNOVATION

Europe's leadership, driven by deep tech innovation, will benefit sectors ranging from renewable energy and agri-tech to construction, mobility, and healthcare.

[The Regional Innovation Valleys \(RIVs\)](#) initiative is one of 25 actions of the New European Innovation Agenda. It aims to harness the full innovation potential across Europe, connecting less and more innovative regions and addressing social challenges through cutting edge technology.

Building on their competitive advantages and complementary strengths, involved regions cooperate to bridge the innovation divide and improve Research & Innovation ecosystems.

PROJECT PRECISEU – Personalised Medicine Empowerment Connecting European Innovation Ecosystems



PRECISEU connects innovation ecosystems across Europe for a truly personalised medicine (PM). It will help transfer practices and solutions from one region to another and scale up deep-tech healthcare innovations based on two enablers: health data (accessible, ethical and interoperable) and advanced therapies medicinal products (ATMPs), a groundbreaking class of innovative medicines, such as gene therapy medicine, delivering targeted treatments and, ideally, curing diseases.

Consortium: **25 partners, 12 European regions, 10 Member States (ES, DE, BE, BG, RO, IT, LT, SE, NL & EL)** and 1 Horizon Europe Associated Country (UA).

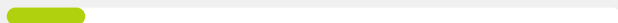

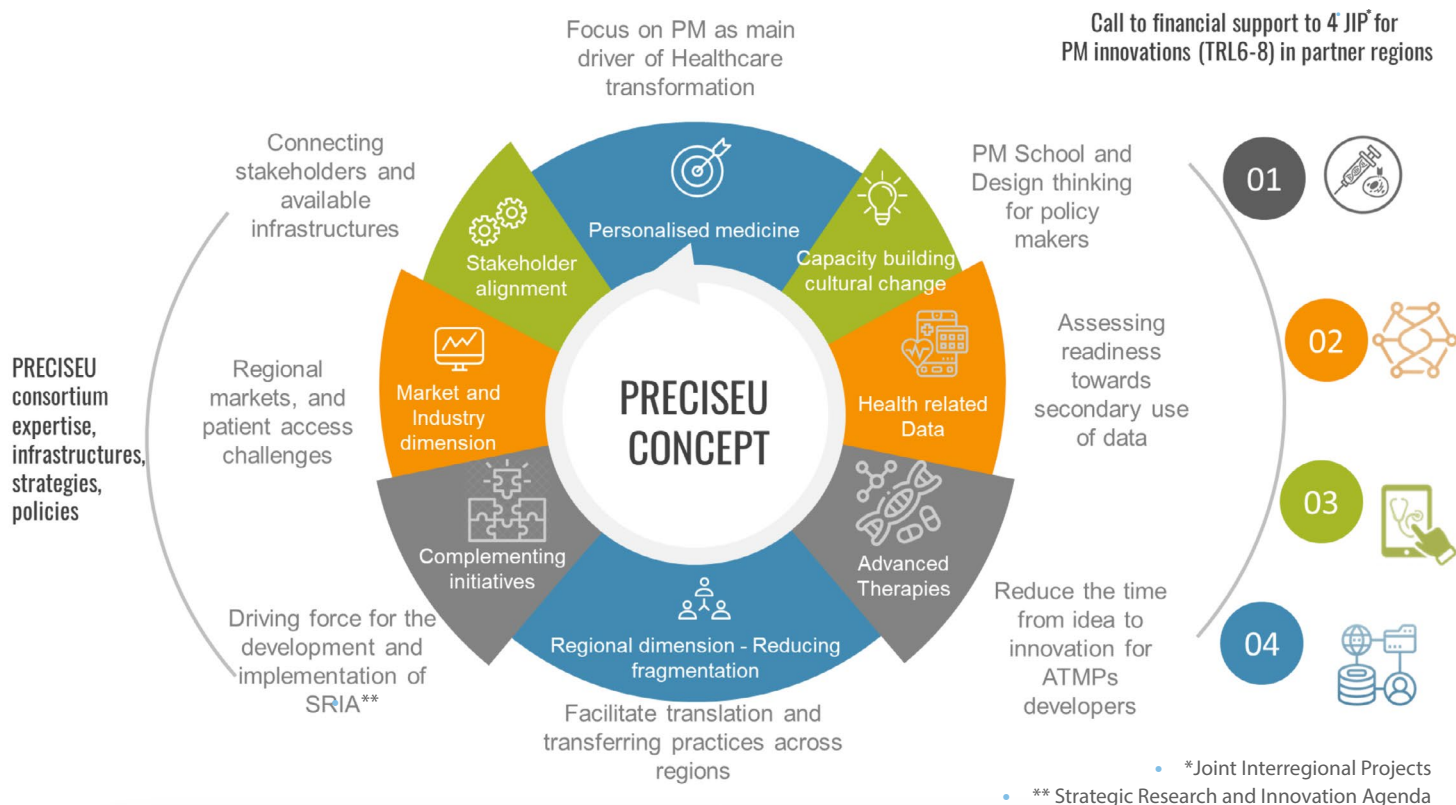
