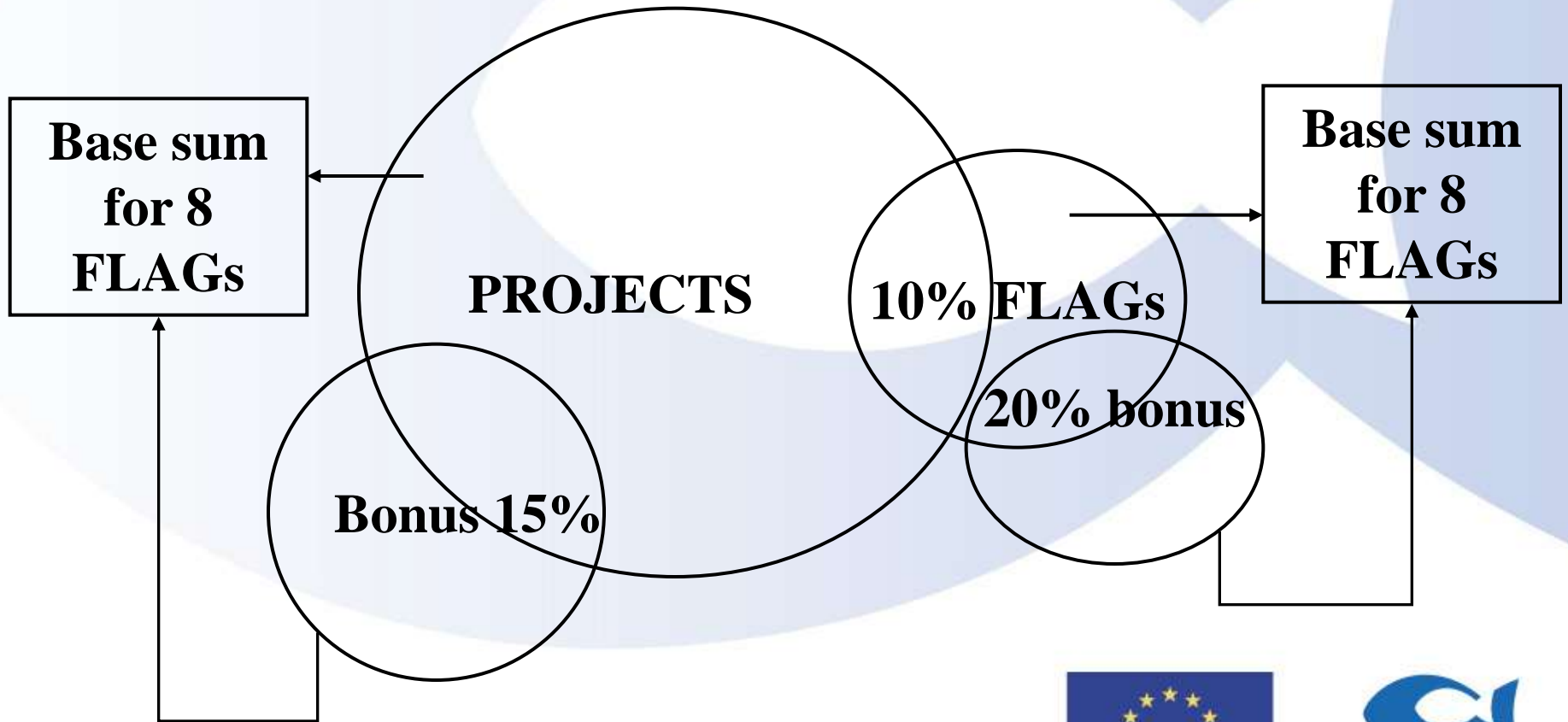

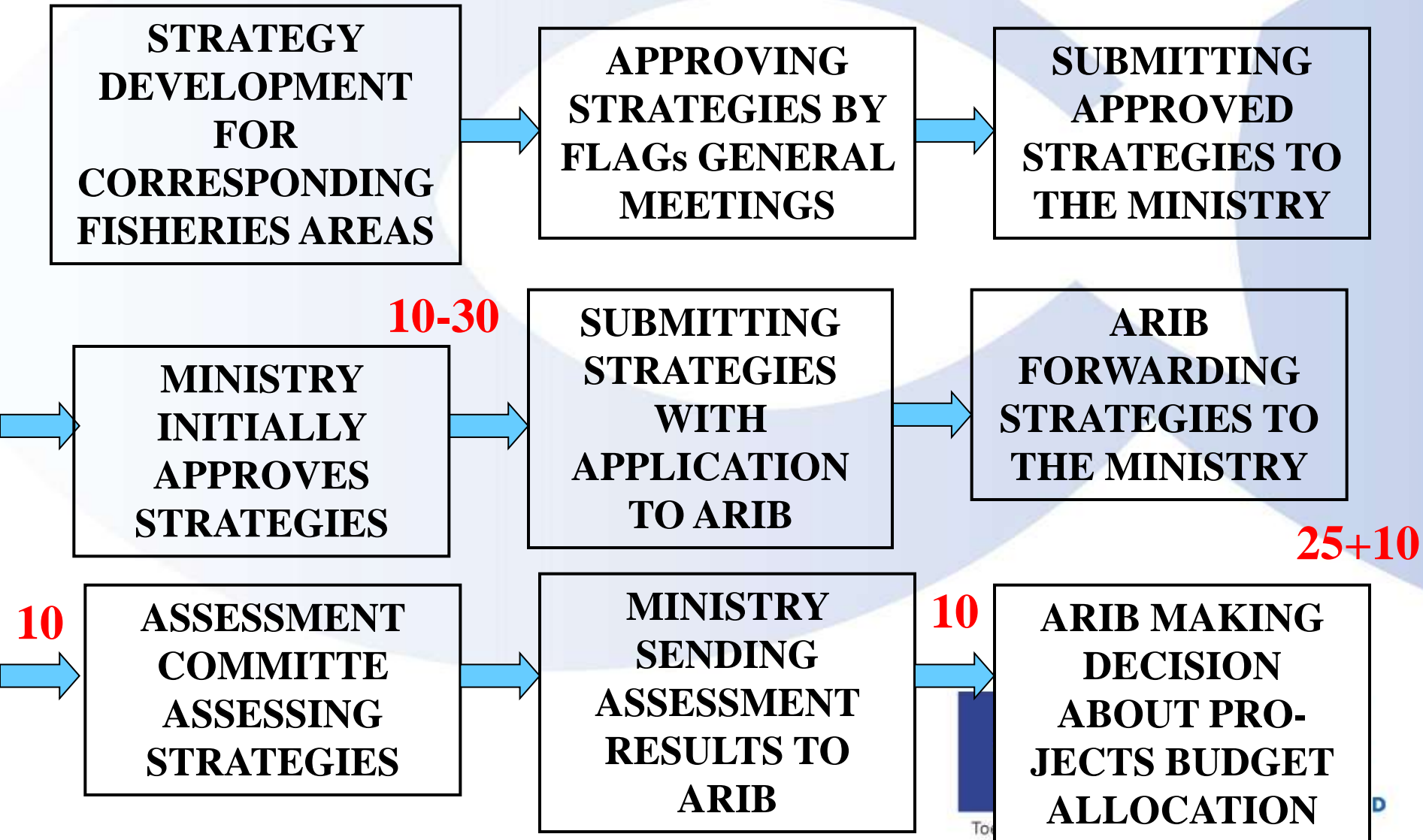
GENERAL BUDGET ALLOCATION OF Axis 4 (national decree)

GENERAL RULES

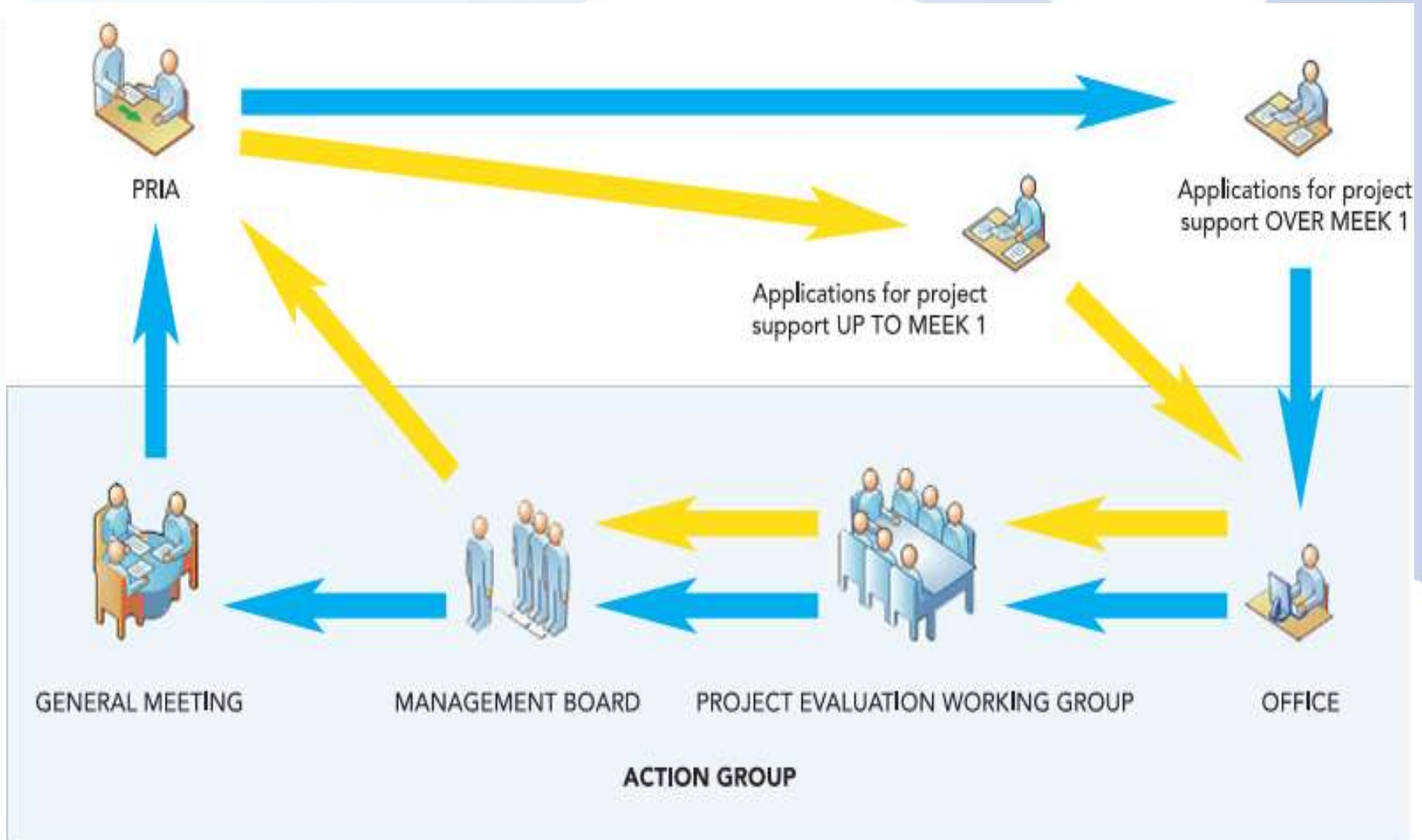
- Fisheries Market Organisation Act establishes framework of market organisation measures, state aid and EFF measures;
- Project eligibility criteria established by national decree (eligible costs and not eligible costs; beneficiaries; co-financing %, etc.);
- Criteria for projects selection established by each FLAG and written down in their strategies;
- ARIB carrying out control over beneficiaries and FLAGs.



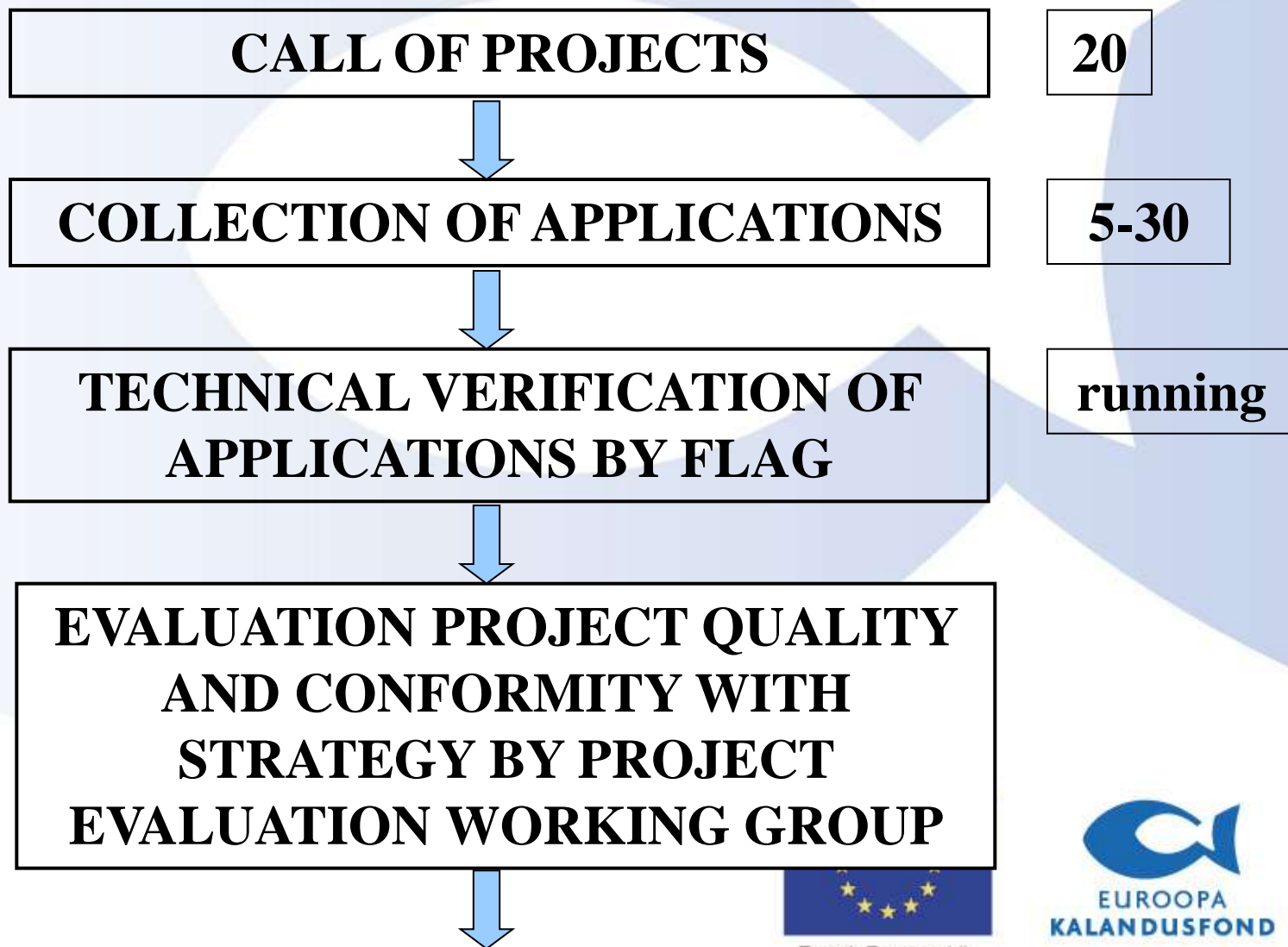

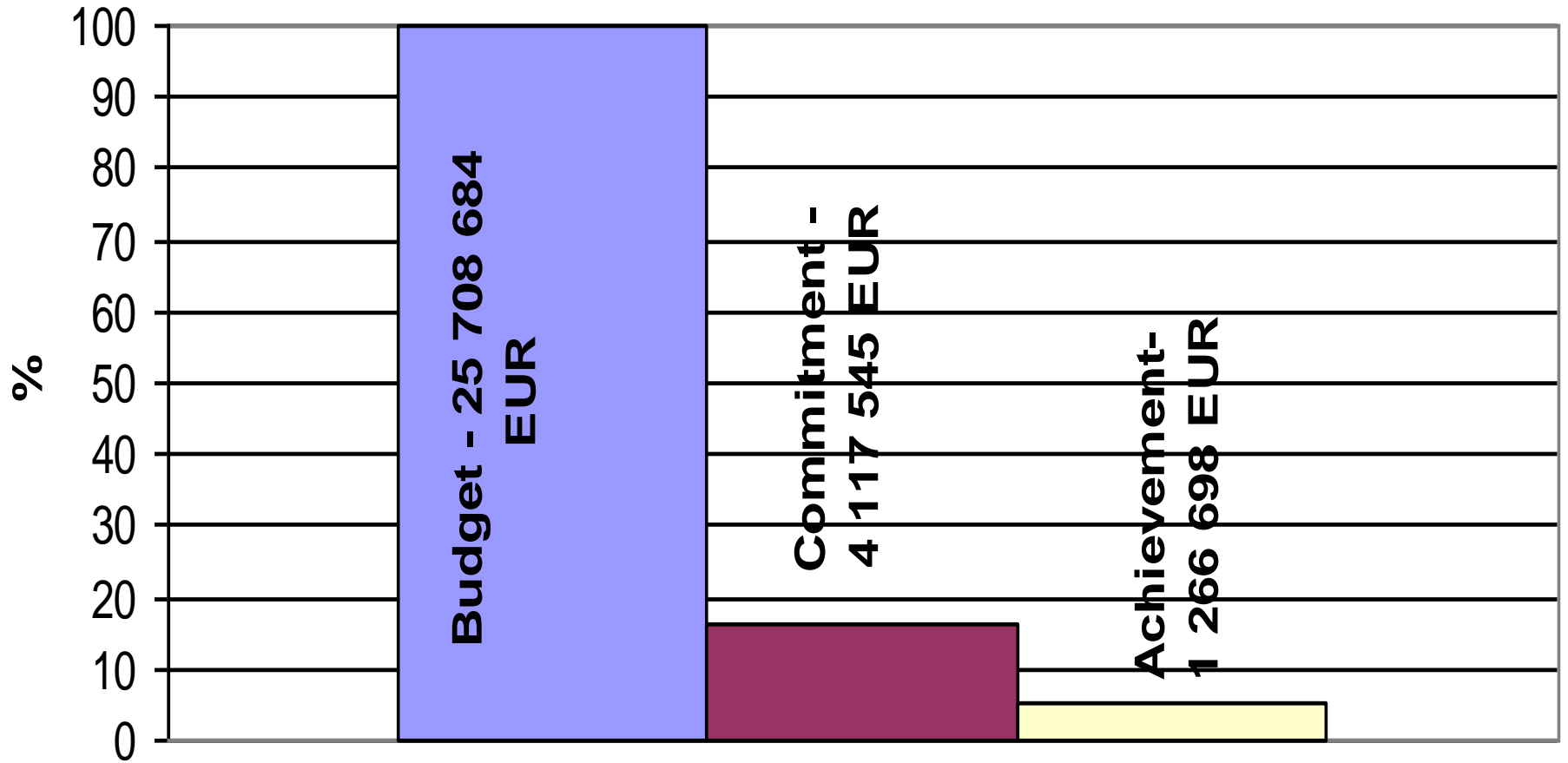

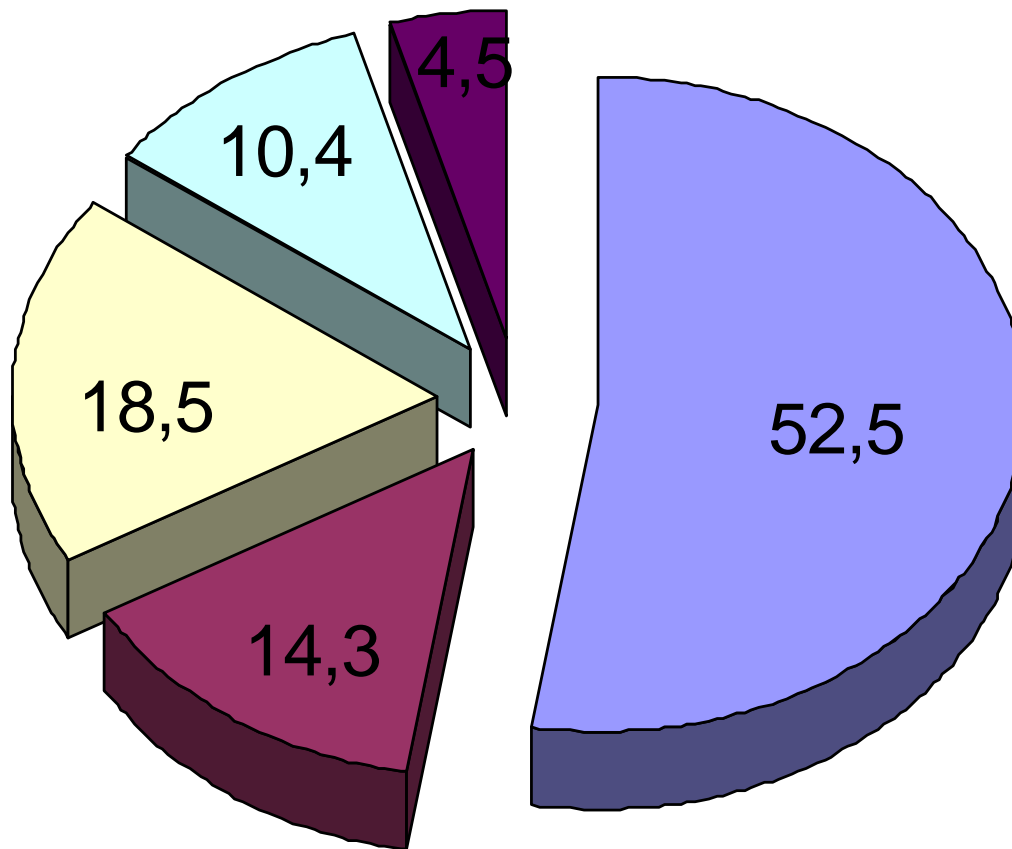
