






Hello! I would like to get support from the FLAG for my project

You have to fill an application form and wait for the decision

How long is the application form?



You have to fill an application form and wait for the decision

How long is the application form?

It is only 15 pages long, but you have to provide 12 attachments:

...confirmation you paid your taxes, confirmation you pay social insurance, confirmation you have money in the bank...



Money in the bank?!

I thought you were going to give me the money!...

Yes, some of it: but you have to pay all the costs first, and then you will get part of the money back



How long will this take?

Between 6 and 12 months



You mean I will get my money back in 12 months from now???



No, you will get it 12 months after you have finished your project...

But I can start implementing the project now?

I wouldn't do it if I were you... You still need to know if your project has been approved


Approved? By whom?





Well, it's complicated. First you have to submit your application to us, the FLAG.

We will decide if we want to support it. The next meeting of our decision body is in March and you will have decision then.



So I can start working in March?

Not yet, your application still has to be approved by our Ministry. We will send all your papers to the Ministry, they will analyse the project and give their approval or not.



Do you mean they will again analyse the project after the FLAG has selected it?

Well, they prefer to check if everything is in good order.
This takes about 6 months



So let me get this right: you will let me know in March if my project can go to the Ministry to be analysed for 6 months...

**...and then I will have
to pay all the costs
and get the money
back in 6 to 12
months?**
