



Introduction

In Latvia during the programming period 2014–2020 there is a possibility to expand LEADER approach by attracting not only the European Agricultural Fund for Rural Development (EAFRD), but also the European Maritime and Fisheries Fund (EMFF). This approach is called community led local development. By realizing approach of community led local development Fisheries local action groups (FLAG's) can contribute competitiveness of the agriculture, fisheries and aquaculture sectors.

The EMFF co-financed investments are restricted to coastal area. At this planning period we have 6 fisheries local action groups.

In order to increase employment and territorial cohesion in fisheries-dependent areas, FLAG's are implementing such specific objective as economic growth, social inclusion and job creation by providing support for employment and labor mobility in coastal and inland communities, which depends on fishing and aquaculture, including the diversification activities in a fisheries sector and into other sectors of the maritime economy.

LIEPAJA DISTRICT PARTNERSHIP

Association "Liepaja District Partnership" was established on September 19, 2006. Local development strategy is implemented in 8 administrative territories and Liepaja city, covering approximately 40 000 inhabitants. Total area 3654 km².


41% of the territory are forest, 45% the utilized agricultural area and 5% of the territory are waters. They have direct access to the Baltic sea 111 kilometres. The most important economic sectors are agriculture, forestry (logging), fisheries and tourism.

On 1 July in 2015 association "Liepaja District Partnership" have 72 members – 8 municipalities, 27 associations and foundations, 12 Ltd., 3 peasant/fishery farms, 2 individual merchants and 20 individuals. Since September 2015 on the basis of the cooperation agreement in the partnership acts Liepaja City Council, Municipalities of Grobina, Nica, Pavilosta, Rucava. Governing structure is divided into council of 13 members and is elected every four years.

During a previous programming period, the local action group did not have any experience of implementing international projects in fisheries, but there have been several exchanges of experience in fisheries and tourism in Lithuania, Estonia, and Northern Poland.



LAUNCHING PRODUCTION OF A NEW PRODUCT AND LAUNCH OF NEW SALES MARKETS

Place of implementation: SIA PIEJURA, Nica rural district, Nica region.

Implementation period: 30 Jan 2017.

Company Piejura was established in Nica, a coastal village of the Baltic Sea, in 1995, which started its operation as a workshop producing hot smoked fish semi-finished products on 13 January 1996. Since then the company has developed both its trade volumes and diversification of its product range under the trends on the market of processed fish products. Canned products were launched into production in 2003. The company has made several investments improve production, environmental protection. and working environment for its staff. Currently, the company produces: 1) canned fish in different packages using a variety of fish species and sauces; 2) fish fingers; 3) smoked fish; 4) both fresh and fried fish fillets; and 5) frozen fish. These product groups are subdivided into several types of produce.

The project was aimed at purchasing specific additional fixed assets to launch the production of new products packaging, fish burgers with filling and without filling packed into thermoformed package. The project resulted in a new product and new packaging. In addition, launching export to Japan and other Asian countries will also be possible (due to a metal detector). For starting the production, the company shall use existing means of production to the utmost by transplanting them and adding new ones from this project, whose technical specification has been specially designed for ensuring a complete production process jointly with the existing means of production. The project will to both the company's contribute competitiveness and sustainable development, and the economics of the local area.

ORGANIZATION «JURKANTE»

The organisation Jurkante was founded in 2008. The members of the organisation: entrepreneurs as well as NGOs and municipal organisations. The organisation operates in Salacgriva district and also in a part of the territory of Limbazi district (Pale, Vilkene and Skulte).





PARTNERSHIP FOR RURAL AND SEA

LAG "Partnership for Rural and Sea" is located in middle of Latvia, near the capital city Riga, territory includes 10 parishes and 1 town – Jurmala. We are 1 of 6 FLAG in Latvia and the LAG area has a 76.4 km coastline and is situated along the Gulf of Riga. The coastal area has a well developed fish processing sector and tourism, but agriculture also makes an important contribution to the local economy, helping to keep the unemployment rate below that of neighboring areas.


The main protected area in LAG territory are Kemeri National Park (31 400 ha), NATURA 2000, Engures lake nature park.



DEVELOPMENT OF PUBLIC FLOATING DOCK IN THE ENGURE PORT



Implementation period: 2014.

Engure is a seaside village, where a strong tradition of fishing and sailing is preserved. The construction of the Engure Port began in 1956, but its construction was never completed, thus only small boats and yachts with a draft of up to 2 m can enter the port. To preserve the fishing and sailing

traditions in Engure, a public floating dock in the Engure Port was installed under the project. Thus, the port infrastructure for the needs of water tourists, coastal fishermen, and water sportsmen was improved. Currently both the students of the sailing school and local fishermen and yachtsmen use the floating dock actively, and international sailing regattas are hosted every year.




PUBLIC AND PRIVATE PARTNERSHIP ASSOCIATION "SERNIKON"

Public and Private Partnership Association "Sernikon" area is located in the metropolitan area of the capital of Latvia, Riga, and it includes Carnikava and Saulkrasti municipalities. At the moment there are 45 members in Partnership, representing municipalities, entrepreneurs, NGOs and individuals. The main element that characterizes the area is 35 km long coastline which is rich in its biodiversity therefore most of it is included in Natural Park "Piejura". All these elements together offers great potential for the development of sectors such as tourism and business. 

TALSI DISTRICT PARTNERSHIP

Society "Talsi district Partnership" is a local action group, founded in Talsi on 21st December, 2004. Until July of 2009 the partnership members are 15 municipalities of Talsi District as well as those participating in organizations and entrepreneurs.

After the territorial reform partnership covers three municipal areas: Talsu district with 4 cities – Sabile, Stende, Talsi and Valdemarpils and with 14 parishes – Abava, Arlava, Balgale, Gibuli, Ive, Kulciems, Laidze, Lauciene, Libagi, Lube, Strazde, Valdgale, Vandzene, Virbi, Roja district and Mersrags district. Currently in partnership operates 19 members – 3 municipalities, 14 societies, 1 Ltd. and 1 private.

STRATEGICAL AIMS

The strategy will be implemented by attracting the funding from the European Agricultural Fund for Rural Development and European Maritime and Fisheries Fund. The European Maritime and Fisheries Fund will be acquired in Roja district and Mersrags district.


- To promote the development of coastal enterprises and innovations.

PROJECT "CONSTRUCTION OF CHILDREN'S PLAYGROUND AT ROJA BEACH", PROJECT APPLICANT ROJA REGIONAL COUNCIL

An objective is to create a well-equipped children's playground in the area of Roja beach diversifying recreational opportunities for families with children.

Place of implementation: Roja beach, Roja village, Roja region.

Brief description: the area of Roja public beach is among the most visited and favourite sites for walking, leisure, and recreation throughout the entire Roja region. Almost ten years ago, Roja Regional Municipality carried out an ambitious beach improvement works by installing wooden footbridges, changing cabins, toilets, benches, as

well as a small children's playground with the EU co-financing being attracted. Some tourists and vacationers at Roja beach is increasing year by year, especially families with children who wish to enjoy swimming in the sea and sunbathing here in the summertime. For this place to be an interesting and exciting site for children, a new, interesting, and attractive playground is developed. Within the project, a children's playground is developed and the area is landscaped by installing benches and garbage bins under this project.

Public funding: 18,000 EUR.



THE NORTHERN KURZEME LAG

The Northern Kurzeme LAG (and FLAG), formed in year 2000, is located in northwest Latvia. The area is bordered by a 144 km stretch of the Baltic coast, from the parish of Jurkalne to the Cape of Kolka, and 12 km of the coastline around the Gulf of Riga.

It consists of municipalities of Dundaga, Ventspils, part of Talsi (parishes of Ive, Lube and Valdgale) – 17 parishes and one town. Total area: 3 492 km². Population: 19 888 (01.01.2016).


The LAG board which is the decision-making body consists of 12 members, but all 56 members of them are actively involved. They represent municipalities, fishermen's organizations, businesses, NGOs and private individuals.

The area's most important asset is the Baltic coast, noted for its natural beauty and its tourism and fishing potential. The area also has a very rich cultural heritage, including religious architecture from the 16–19th century, Baltic German manor buildings, and Suiti (a small catholic community) and Liv (a Finno-Ugric ethnic group) traditions. The coastal area has large beaches, which support many business activities, mostly in the tourism sectors. Extensive forests cover about 71% of the area.

- To promote the values of nature and to succeed the conservation of coastal environment.
 - To promote micro, small and medium businesses in fisheries.
 - ▶ To promote the growth of public organizations and local fishery communities.

EXPIERENCE ON TRANSNATIONAL COOPERATION

The Northern Kurzeme FLAG has begun negotiations and an exchange of views with the Estonian NGO Development Centre and Estonian LAG "Green Riverland" on a common international progress of the project, which still intend to engage partners from Slovenia and Portugal.

It has signed a letter of intent with Poland LAG "Morenko" on cooperation in fisheries development and exchange of experience.
