## **EXPLANATORY MEMORANDUM**

### **1. CONTEXT OF THE DELEGATED ACT**

Annex I to Commission Delegated Regulation (EU) 2017/2055 specifies the format of the relevant unique identification number for each Member State. According to Annex I, for Denmark the ID number type for a natural person is the personal registration number (CPR number).

It should be clarified that a Danish ‘sole proprietorship’ (in Danish ‘Enkelthandsvirksomheder’) shall use the company registration number (CVR number) and not the CPR number.

### **2. LEGAL ELEMENTS OF THE DELEGATED ACT**

Article 1 of this Delegated Regulation corrects Annex I to Commission Delegated Regulation (EU) 2017/2055.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Directive (EU) 2015/2366 of the European Parliament and of the Council of 25 November 2015 on payment services in the internal market, amending Directives 2002/65/EC, 2009/110/EC and 2013/36/EU and Regulation (EU) No 1093/2010, and repealing Directive 2007/64/EC<sup>1</sup>, and in particular Article 28(5) thereof,

Whereas:

- (1) Annex I to Delegated Regulation (EU) 2017/2055 contains an error as regards the applicable unique identification number for Denmark. The error affects the substance of that Annex.
- (2) Delegated Regulation (EU) 2017/2055 should therefore be corrected accordingly,

HAS ADOPTED THIS REGULATION:

*Article 1*

Annex I to Delegated Regulation (EU) 2017/2055 is corrected in accordance with the Annex to this Regulation.

*Article 2*

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.
